




THE GRAND RIVER


- Grand River







MICHIGAN LEGISLATURE PUBLIC ACT 358 OF 1891

The permanent establishment of dock, safety, sanitary, and building lines along the...
Grand River...within the City of Grand Rapids.

Property owners continued to fill in property along the Grand River (the railroad built a line along the river), narrowing the river and increasing risk of flooding.






GRAND RIVER FLOOD 1883 LOG JAMS





Out of concern over installing a trunk sewer in Market Avenue, the City installed the sewer along the dockline wall. (12' x 13' box)


FLOOD PROTECTION CONSTRUCTION 1997-2003 (SECOND ROUND)

- Wall rehabilitation























FLOOD PROTECTION CONSTRUCTION 2015-2017 (THIRD ROUND)




- Post Katrina- Raise Flood Protection System from 1' to 3' above the 100-year flood elevation. If not, homeowners would lose federal flood insurance.

GRAND RIVER RESTORATION PROJECT

- ► Habitat enhancement
 - ▶ 12 acres of limestone bedrock shoals for sturgeon spawning
 - ▶ 5 times the increase in species diversity
- Recreational enrichment
 - ▶ 2.5 miles of drift boating reach, downstream passage of paddle and oar boats
 - ▶ 400 meters of International Canoe Federation local merit slalom course
- Aesthetic improvements
 - ▶ 2 new riverside parks
 - ▶ 4 acres of native riparian forest




